

## Sweden Hate Crime Report 2015

### Summary

Sweden regularly reports hate crime data to ODIHR. Hate crime reports are [published](#) every second year. Since 2016, the Government has implemented a national plan against racism, similar forms of hostility and hate crime. The plan takes an integrated approach and comprises strategies and measures to prevent and combat racism and hate crime through co-ordination and monitoring, education and research, and support for and co-operation with civil society.

Three different victimization surveys are conducted at one, two and three-year intervals in order to measure unreported hate crime.

### ODIHR's Key Observation

ODIHR observes that Sweden has not reported information on sentenced hate crime cases to ODIHR.

# Official Data

Figures reported to ODIHR comprised 6,984 estimated hate crime reports. This number included incidents related to defamation, hate speech, and unlawful discrimination. The number displayed represents only hate crimes according to the OSCE definition. The number of prosecuted cases reflects prosecutorial decisions taken in 2014, only submitted in 2016 due to the reporting cycle.

## Police data by bias motivation

3,119

### Racist and xenophobic hate crime

Official figures recorded 3,119 racist and xenophobic crimes, of which 548 were physical assaults, 691 cases of vandalism or damage to property and 1,880 threats.

### Hate crime against Christians and members of other religions

Official figures recorded 645 anti-religious hate crimes, of which 354 were motivated by bias against Christians.

### Anti-LGBTI hate crime

Official figures recorded 433 crimes motivated by bias based on sexual orientation.

### Anti-Muslim hate crime

Official figures recorded 369 crimes motivated by anti-Muslim bias, consisting of 46 assaults, 76 cases of vandalism/damage to property, and 247 cases of threats.

### Anti-Semitic hate crime

Official figures recorded 149 anti-Semitic crimes, including eight assaults, 14 cases of vandalism/damage to property and 127 cases of threats.

### Anti-Roma hate crime

Official figures recorded 144 crimes motivated by bias against Roma and Sinti, including 40 physical assaults, 12 cases of vandalism or damage to property and 92 cases of threats.

## Police data by type of crime

### Threats/ threatening behaviour

Includes crimes that are officially categorized as 'unlawful threats and non-sexual molestation'.

1,054

### Vandalism

Includes crimes that are officially categorized as criminal damage/graffiti.

### Physical assault

Includes a selection of crimes of a violent nature: homicide, assault and violence against a public servant.

## National Developments

The **Swedish National Police Board** continued its project aimed at increasing efforts to counter hate crimes, which was extended until May 2016. The **Swedish Police Authority** western region began preparatory work for the establishment of a special team to investigate hate crimes and started developing a regional action plan to counter hate crimes. The **Swedish Prosecution Authority** designed a study to review 300 cases of hate crime to improve the quality of legal proceedings and organized a hate crime seminar to increase the competence of hate crime prosecutors.
